#### **Bank Merger Completed**



CBI Sign Goes Up at Paul Revere Square Davenport on June 8, 2020.

The merger of Walcott Trust and Savings Bank into CBI Bank & Trust was completed over the weekend of Friday, June 5 through Sunday, June 7, and all customer accounts were converted over to the CBI data processing system.

"We're pleased to announce the successful completion of our plan that was put in motion last year," said Greg Kistler, President and CEO of Central Bancshares, Inc., the parent company of both banks. "The fact everything went so smoothly is a testament to months of planning, coordination and hard work by a number of talented individuals throughout our organization. I'm extremely proud of their efforts."

Walcott Trust and Savings Bank, which was organized in 1893, had total assets of approximately \$125 million and served a primary market area of Scott and northeast Muscatine Counties in Iowa through two locations: 101 West Bryant Street in Walcott and 2322 East Kimberly Road in Davenport. It was acquired by Muscatine-based Central Bancshares, Inc. in December, 2019.

The weekend merger lifted CBI Bank & Trust's total assets to over \$650 million. In addition to the two former WTSB locations, it has banking centers in downtown Davenport, Coralville, Kalona, Muscatine, Washington and Wilton in Iowa, and Buffalo Prairie in Illinois, and serves over 20,000 households and businesses.

#### **Accessory Buildings**

Storage sheds are accessory buildings, which are regulated under the Walcott Code of Ordinances in Chapter 167, Zoning Regulations. A permit and approved site location sketch are required before you begin your project. In residential R-1 and R-2 zones, properties are allowed to have a private garage, attached or detached, and one additional accessory building. Accessory buildings are only allowed in the rear yard and according to City Code, houses located on corner lots are considered to have two front yards. In addition, accessory buildings cannot be placed on utility easements.



#### Pre-need Eligibility Offers Peace of Mind

Many veterans don't realize that their military service entitles them to be interred in a national cemetery at no cost to them or their families.

Even if you never received disability or any other benefit from VA, if you served on active duty and were discharged under conditions other than dishonorable, you are eligible. If vou served in the National Guard or reserve and were mobilized or served long enough to earn a retirement, you are eligible. Yet most veterans and their families don't take advantage of this benefit, which would save them thousands of dollars. The best, most effective way to ensure you get the burial or memorial benefits you and your spouse have earned from military service is through a VA program called Pre-Need Eligibility (Pre-Need).

Pre-Need establishes eligibility for VA burial and memorial benefits before you die, so your family doesn't have to go searching for documentation at the time of your death. Simply fill out VA Form 40-10007 and mail it in to the St. Louis office indicated on the top of the form. You can print out a form or fill it out on line at www.cem.va.gov/preneed.

VA will review your application, and you will get a letter confirming or denying eligibility. If approved, place the letter in a safe location, inform your family and rest easy.

Pre-Need Eligibility provides veterans and their families with peace of mind. This information is particularly important for members of the National Guard and reserve, many of whom don't realize that their service entitles them to burial benefits.

There are some nuances for reservists, who may have to provide additional documentation if a mobilization isn't documented on their DD 214, so it is even more important for them to apply for Pre-Need.

Waiting for your family to try to establish your eligibility at the time of death can sometimes result in a non-eligible decision with little or no time to provide additional information. You owe it to your family to take care of this while you are still alive.

If a VA national, state or tribal veterans cemetery is selected as the final resting place, a veteran will receive the following: gravesite, opening and closing of the grave, grave liner, and perpetual care of the gravesite. Also included are memorial benefits such as a headstone, marker or cover for a columbarium niche.

All are free, which means saving the veteran's family thousands of dollars. The veteran's spouse, as well as minor children and unmarried adult children who legally rely on the veteran for support, are also eligible for interment free of charge, typically in the same grave or columbarium niche as the veteran.

If the veteran chooses interment in a private cemetery, he or she can still have a free government-furnished headstone, marker or cover. If the veteran chooses to be buried in a private cemetery with a privately purchased headstone, marker or niche cover, the family may request a free bronze medallion with the word "Veteran" and the appropriate branch

of service to attach to the headstone. Each veteran's family also receives a burial flag.

At many VA national cemeteries, NCA partners with local military units or veterans service organizations to provide deceased veterans with military funeral honors, including the playing of taps and presentation of the burial flag.

Finally, upon request, the veteran's family will receive a Presidential Memorial Certificate signed by the president.

Multiple copies can be requested. VA encourages all veterans to take advantage of PreNeed Eligibility to ensure that they, and their families, know their eligibility status in advance. While families can always apply for the benefit at the time of death, applying in advance brings peace of mind and can help resolve eligibility problems ahead of time, when the person who knows the most about his or her service - the veteran - is still around to answer questions.

The 2019 tax return deadline has been extended to July 15th 2020. A Roth IRA allows individuals to invest in a wide variety of investments, including stocks, bonds, mutual funds, etfs, CDs and money market.

#### **Additional Rules**

**Spousal Contributions** - Contribution can be made for a non-working spouse if the couple is married, files a joint return and the working spouse has taxable compensation.


#### **Conversions**

A Roth conversion is a strategy used by individuals with an existing 401k or traditional, SEP, or SIMPLE IRA.

#### **Distributions**

#### Storing Gasoline Safely at Home

As summer begins, many of us must store portable gasoline containers to operate lawnmowers, garden equipment, chainsaws and so on. Improper storage can result in devastating fires or explosions, destroying homes and causing injury or death. Gasoline powered engines are everywhere, but never forget the volatile, highly explosive qualities of gasoline. When mixed with the right air proportions, one cup of gasoline vapor has the explosive power of about five pounds of dynamite, enough force to destroy any home or car.

Remember, there is no completely safe way to store gasoline, and small mistakes can have catastrophic consequences. Treat this explosive substance with the extreme care it requires.

- Never store gasoline in non-approved containers. Do not use glass or non-reusable plastic jugs or containers.
- Never use gasoline as a cleaning agent or solvent.
- Never bring gasoline in the house. Store in the garage or better yet, store in a well-ventilated shed away from the house



- Do not use or store gasoline near any possible ignition sources such as a pilot light, electrical device or gas appliance.
- Do not refill power equipment while hot or running.
- Keep gasoline storage at the very minimum needed.
- This summer and every season, recognize and respect the explosive dangers of gasoline.
