

Special Personal Property Coverage

Homeowner insurance policies are intended to cover a person's home and contents. Typically, a policy will cover the personal property for a percentage of the dwelling amount (usually ranging from 50-75%). If your home is insured for \$300,000 and your personal property coverage is 50%, you will have up to \$150,000 coverage for your contents. In order to keep policies affordable to the average person, special policy limits apply to certain items. If you own high value items, you may find your coverage is not sufficient.

What types of personal property may require special coverage?

One common item that you should be aware of includes expensive jewelry, and wedding rings. Firearms, musical instruments, coin collections, silver, gold and furs are other items to consider. If you have an extensive art or an antique collection including certain rare collectibles, these also may require special coverage. Remember too, the value of these items may increase over time and your policy should be adjusted accordingly.

How do I properly protect my high-value property?

The best way to increase coverage for high value personal property is to use a scheduled personal property "rider." This is a separate endorsement that lists the item and maximum amount insured. An advantage to the rider is that all risk coverage is provided and not just limited to the covered peril such as wind, fire or theft, which is provided by your regular personal property policy. Usually, riders are subject to lower or no deductibles.

Communicate with your agent about the things you have to protect, and together you can tailor a policy to make sure you have the coverages you need. The time to do this is now, before you have a loss.

The Greatest of These is Love

Here we are, already in the month of February, the month of love. The flower shops experience their busiest time of the year, lovers exchange romantic cards and gifts, couples plan cruises, and some even get married on Valentine's day.

The 13th chapter of 1 Corinthians is very popular in the month of February and is used frequently in wedding ceremonies. It is pegged the "love chapter." If we only read verses 4 through 7, it certainly sounds like good lessons for newlyweds. It points out two things that love is and eight things love is not. The NIV version reads this way:

"⁴Love is patient, love is kind. It does not envy, it does not boast, it is not proud. ⁵It is not rude, it is not self-seeking, it is not easily angered, it keeps no record of wrongs. ⁶Love does not delight in evil but rejoices with the truth. ⁷It always protects, always trusts, always hopes, always perseveres."

The King James version uses the word *longsuffering* instead of the word patient, which means that we are patient, *put up with* all those things we do not like, plus all the annoying and hurtful things for a long time because of love—love endures the test of time.

Shortly after my husband and I got married, I asked him to make of list of what he expected from me in our marriage. I also asked him to tell me what he loved about me. I guess at that time I was very insecure, being divorced and coming out of an abusive marriage, I needed to know these things. To see it in writing, I could review it again and again if I needed to. It is not in his nature to tackle such a task, but he reluctantly wrote the lists and gave them to me. It was 28 years ago on Valentine's Day that we were married—yes, we were one of those couples married on Valentine's Day.

I have looked at those lists many times over the years, and it is amazing that he unknowingly wrote the lists with some of the very principles that Paul wrote about in this letter. We both have succeeded and we both have failed in some ways, but we certainly have been longsuffering with each other over the 28 years. I was searching for a file on my external hard drive and I came across those very lists just before I started writing this article. I strongly believe that the Lord wanted me to read them once again! A very timely find indeed!

However, as we explore further in Chapter 13, is Paul writing about what love is between couples or is it a message about love between all of us, a *brotherly love* so to speak? Is it discussing the status or condition of our hearts? Let us look at what verses 1-3 say:

"IThough I speak with the tongues of men and of angels, but have not love, I have become sounding brass or a clanging cymbal. ²And though I have the gift of prophecy, and understand all mysteries and all knowledge, and though I have all faith, so that I could remove mountains, but have not love, I am nothing. ³And though I bestow all my goods to feed the poor, and though I give my body to be burned, but have not love, it profits me nothing."

Paul makes it clear that without love as the motive, these gifts and acts are meaningless. Even the most dramatic actions of self-denial or selflessness, are profitless, pointless, useless, and to no purpose without the motivation of love. Love is selflessness—self-denial for the sake of another.

Verse 13 ends the chapter with, "And now abide faith, hope, love, these three; but the greatest of these is love." These **three** are more precious than the gifts that the Holy Spirit gives us. We are to pursue faith, hope and love, but the **greatest** of the three is love.


Are we patient? Are we kind? Are we envious? Are we boastful? Are we proud? Are we rude? Are we selfless? Are we easily angered? Do we keep records of wrongs? Do we rejoice in truth or do we delight in evil? Do we protect, trust, hope and persevere? Looking back, verses 4-7 paint a picture of the actions of love; they clearly define Christ's love for us. We are to pursue the examples of Christ and live a Christ-like life. This is not an easy list. Jesus commands us all in John 13:34-35,

"34 A new commandment I give to you, that you love one another; as I have loved you, that you also love one another. 35 By this all will know that you are My disciples, if you have love for one another."

We should carry this list with us and look at it daily. Are we up for the challenge? My prayer for all of us is to pursue the life of love that Christ has shown us. May God bless you in this quest.

Were you impacted by the 2020 Midwest Derecho?

Individuals impacted by the 2020 Midwest derecho are being recruited to participate in a research study on social networks and support. It is being carried out through the University of South Florida Anthropology Department. This project is exploring how people used their social networks to access social support after the storm.

To be eligible you must be 18 years of age or older and were impacted by the 2020 derecho in anyway (examples: electricity loss, financially impacted, property damage, emotional/mental distress, etc.).

Participation includes a 15-minute online survey and/or an optional telephone interview. Participation is voluntary and you will not receive any direct benefit or compensation. All personal information will be kept confidential.
