

ORDINANCE NO. 541-23

AN ORDINANCE AMENDING CHAPTER 165 OF THE CODE OF ORDINANCES OF THE CITY OF WALCOTT, IOWA, PERTAINING TO BILLBOARDS

BE IT ENACTED by the City Council of the City of Walcott, Iowa:

SECTION 1. SUBSECTION MODIFIED. The Code of Ordinances of the City of Walcott, Iowa, is hereby amended by repealing the following Subsections 165.05(2)(J)(5), 165.05(2)(J)(6), and 165.05(2)(L).

SECTION 2. SUBSECTION MODIFIED. The Code of Ordinances of the City of Walcott, Iowa, is hereby amended by adding to Subsection 165.06(4)(A) thereof (Permitted Signs), which is hereby adopted to read as follows, in alphabetical order:

Billboard Signs

SECTION 3. SUBSECTION MODIFIED. The Code of Ordinances of the City of Walcott, Iowa, is hereby amended by adding a new row to the table in Subsection 165.06(4)(C)(1) thereof (Individual Sign Allowances), which is hereby adopted to read as follows, in alphabetical order:

Billboard Signs: Maximum area: 672 square feet per sign face
Maximum height: 107 feet above the crown of the overpass on I-80 and Y-40 roads

SECTION 4. REPEALER. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 5. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.


SECTION 6. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.


